In the event of such restriction or removal, STYLECAREERS, LLC shall not be liable for any refunds or other exhibit expenses incurred by Exhibitor. Exhibitor shall not assign, sublet, or share the space allotted without the written consent of STYLECAREERS, LLC.

**TAXES AND LICENSES:** Exhibitor shall be responsible for obtaining any licenses, permits or approvals required under local or state law applicable to their activity at the exposition. After the cancel without penalty date, STYLECAREERS, LLC will not refund any payment and all contracts will be due in full.**

**EXHIBITION POSTPONEMENT AND/OR CANCELLATION:** STYLECAREERS, LLC, in its discretion, shall have the right to postpone or cancel the exhibition and shall not be liable in any way to the Exhibitor for losses resulting from such delay or cancellation. STYLECAREERS, LLC will not be liable for the fulfillment of this contract as to the delivery of exhibit space if non-delivery is due to any of the following causes: reason of the facility being damaged or destroyed by fire, act of God, public enemy, war or insurrections, act of terror, strikes, the authority of the law, postponement or cancellation of the exposition, or for any cause beyond its control.
